Target Hunger food services include the operation of three pantry sites, drive thru produce distributions twice a week, mobile pantry sites, emergency food assistance, and spring and summer break food programs for children. In 2025, Target Hunger served over 25,000 unique individuals from more than 208 zip codes, reaching nearly 10% more households than the year before.

The Navigation Program, staffed by a team of bilingual Community Health Workers, assists clients in a myriad of ways including but not limited to rent and utility help, healthcare enrollment, and job training. These resources, in tandem with our food programs, help stabilize the health, finances, and overall well-being of Target Hunger families.

Target Hunger staff, volunteers, and community members maintain two edible gardens, the Willie G. & Gladys R. Goffney Community Garden located in Kashmere Gardens and the Shotwell Garden located at our main warehouse, which harvested food is distributed to clients.
